

J.C. Mfg., Inc. Limited Warranty

JC Mfg. Inc. warrants each new JC pontoon boat for a period of five (5) years. The five year portion of the warranty refers to the carpet, canvas and vinyl. All other equipment and mechanicals above the deck will be warranted for a period of five (5) years. In addition to this five-year limited warranty, JC Mfg. Inc. also provides a limited lifetime warranty on the decking, pontoon tubes, transom and rail system of the boat. This warranty is subject to the following terms:

This warranty extends to the original retail purchaser only and becomes effective on the date of original retail purchase. This warranty does not cover boats purchased for or used for any commercial purchase; including, but not limited to, boat rental. This warranty does not cover any boat that has been subject to misuse, negligence, accident or damage resulting from use of motors in excess of rated horsepower. In addition, this warranty does not cover any damage caused by operation of the boat in extreme weather and sea conditions. Damage to the hulls and/or structure determined by JC Mfg. Inc. to have been caused by either electrolysis or improper trailering of the pontoon will not be covered under warranty. Limited warranty card must be on file at JC Mfg., Inc.

JC Mfg., Inc. warrants all pontoon tubes against leakage due to flaws in workmanship; specifically, defects in welding, cracking in welds or stress points and/or any other defects which cause the tubes to be structurally unfit for their designed application.

JC Mfg., Inc. warrants the plywood decking in all JC pontoon boats against failure due to fungal decay, termite damage, delamination or structural failure in normal recreational usage. Limited warranty provides for replacement plywood and labor directly associated with deck repairs for the first ten (10) years from the date of manufacture. After ten (10) years the warranty provides for replacement of plywood only. Carpeting and vinyl are not considered part of decking and will be subject to the five (5) year limited warranty only.

Repair or replacement qualifying under this warranty will be performed by an authorized JC Mfg., Inc. dealer or the factory. The boat and/or any defective part must be returned to the dealer or factory (whichever is necessary) within the warranty periods. Any warranted part found in the reasonable judgment of JC Mfg. Inc. to be defective in material or workmanship will be repaired or replaced by the dealer or the factory under terms of the warranty. The expense of returning boat or part to dealer or factory and expense of returning boat back to owner will be paid by owner. Proof of purchase will be required by an authorized dealer to substantiate any warranty claim.

JC Mfg., Inc. assumes no responsibility for loss of use of boat, loss of time, inconvenience or other damage or otherwise including, but not limited to, expense of returning boat for service and expense of returning boat back to owner, mechanics travel time, in and out of water charges, telephone charges, trailering or towing charges, rental of another boat during the time warranty repairs are being performed, travel, lodging or damage to personal property or loss of revenue.

The responsibility and warranty of JC Mfg., Inc. under this warranty in respect to claims is strictly and exclusively limited to making the required repairs or replacements of defective parts. No claim of breach of Warranty shall be the cause for cancellation of contract of sale of any boat. In addition, JC Mfg., Inc. does not authorize anyone to assume for them any obligation.

JC Mfg., Inc. reserves the right to change or improve the design of any boat without assuming any obligation to modify any boat previously manufactured.

All implied warranties are limited in duration to one (1) year.
